Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties of any and all liability and responsibility of any loss, damage, accident or injury which may occur to me, my child and/or children, any minors(s) that I am representing myself as the legal guardian of, my horse(s) and/or any horse(s) being used on the premises on my/their behalf, and any and all property belonging to and/or being used by me/them while on said premises and/or engaging in any activities thereof. I also assume and accept full responsibility and liability for any and all damages caused by me and/or them, my and/or their horse(s), and/or any horse(s) being used on the premises on my/their behalf.

I am aware that horseback riding is an athletic event which poses potentially serious risk of accidents, injuries or death to it's participants. I understand that any and/or all horses I/they may be involved with, my/their, horse(s) or I/they may be injured or die as a result of my/their negligence, the negligence of others, or through no fault of myself/them or anyone, because the nature of activity and/or activities in which I/they are going to be engaged in. I also understand that horses and terrain can be unpredictable and even the most well trained horses are often unpredictable and difficult to control. Furthermore, I understand that Back To Basics Horse Show Association, Lucky Drive Ranch, Mary F. and or Edward A. Hawley do not warrant or represent that the premises on which, including, but not limited to, all grounds, bards, riding areas and riding rink, I/they are to be participating in activities on to be safe, healthful or suitable for the purpose any activities, horse or otherwise, for which they are being used. I further attest that I am aware of any and all risk of horse related events and/or activities.

With this waiver/release I accept notice of the provision of Section 3.1-796.130 through 3.1-796.133 of the Code of Virginia, which states in part: that there are inherent risks in equine activities, including (I) the propensity of an equine to behave in dangerous ways which may result in injury to the participant; (II) the inability to predict an equine's reaction to sounds, movements, objects, persons or animals; and (III) hazards of surface and subsurface conditions.

Furthermore, with this document, I, both on my and their behalf, expressly assume risk of loss, damage, accident, injury or death due to the negligence by and/or because of Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties for my/their safety.

With the knowledge of the foregoing, and as an inducement for Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties, I hereby agree to waiver/release (give up) any and all rights that I and/or my heirs, they and/or their heirs may have to make a claim or claims against same arising from any and all losses, damages, accidents, injuries or death which I/they, might sustain or which might occur to my/their horse(s), and or any horse(s) being used on my/their behalf, as a result of my/their participation in any and all activities on the behalf of or for the benefit of Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties.

I further agree to indemnify (hold harmless) all of the foregoing from any claims which I might make or which might be made on my/their behalf against me/them, by others arising from my/their participation in any and all activities with Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties, either on horseback, on foot, by automobile or any other means. I agree that I am requesting permission for myself, my child and/or children, and/or any minor(s) I am representing myself to be the legal guardian of, to participate in any and all activities, on the behalf of, or for the benefit of Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. I represent that I have the authority to give this release.

In exchange for me/them being permitted to participate in these activities, for myself and/or them, my/their heirs, guardians, and legal representatives, I release and agree not to make or bring, have made or brought, any claim of any kind, including medical and/or legal fees and any and all claims of collection for damages, against Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. I understand/agree that in all contents of this document where their, they, and them, etc. is used instead of my child and/or children and/or minor(s) I am representing myself to be the legal guardian of, it is the same as the full referral being used and is legal and binding according to same. I further attest that I am aware that it is a felony to falsify and/or misrepresent myself as a parent and/or legal guardian of a minor and Back To Basics Horse Show Association, Lucky Drive Ranch, Edward A. and/or Mary F. Hawley, their agents, employees, staff, guest, participants and any and all designated representatives of said premises and/or parties cannot and will not be liable and/or responsible for claims of loss, damage, accident, injury or death which may be levied against them as a result of my illegal misrepresentation.
